Awarded Ph.D. degree and discontinued Ph.D. education

The universities report all awarded Ph.D.-degrees as well as discontinued Ph.D.-educations to Statistics Denmark

In order to collect all relevant data for the reporting, the universities may in some cases ask the students to answer the attached questionnaire.

- All Ph.D. students, who have discontinued their Ph.D. education at the institution, must be reported.
- Discontinuation may take place in connection with obtaining the Ph.D. degree.
- Discontinuation must also be reported, if the student has discontinued the education without passing the Ph.D. degree. Please note that any breaks due to leave, study periods abroad, sickness leave, are not reported as discontinuation.
- If there is a change of institution, the discontinuation must be reported by the institution from which the transfer takes place.
- Consequently, it is the actual ending of the Ph.D. education at the institution in question, which decides when a discontinuation is to be reported, and not the discharge from the institution.
- Please note that persons, whose thesis has been assessed in accordance with paragraph 15, subsection 2 or subsection 3, must also be reported. In this context, the reporting is effected in connection with completion of the project, either when the Ph.D. degree is granted to the person or if a negative decision is put forward by the assessment committee of the thesis or defence. In these cases also the questionnaire related to the newly enrolled Ph.D. students must be reported.
